Terms of Use

Introduction

KYKLAMINO (referred to as "KYKLAMINO," "we," or "us") provides this website (the "Site") for informational and recreational purposes related to our family leisure and activity venue in Moni, Limassol, Cyprus. These Terms of Use ("Terms") govern your access to and use of the Site. By accessing or using our Site, you agree to comply with these Terms. If you do not agree, please do not use the Site.

We may update or modify these Terms from time to time. Any changes will be effective once posted. It is your responsibility to review these Terms periodically. Continued use of the Site after changes are posted constitutes acceptance of the revised Terms.

Scope of Website Use

You may use this Site solely for personal, non-commercial purposes to learn about KYKLAMINO's services, make inquiries or plan visits. All content and materials on the Site (including text, images, graphics, logos, videos and software) are provided for general information about our venue and services. You agree to use the Site only for its intended purpose and in accordance with these Terms and applicable laws.

User Obligations and Conduct

When using our Site, you agree to:

- **Provide Accurate Information:** Ensure that any information you submit (for example, through contact or reservation forms) is true, accurate and up-to-date.
- **Lawful Use:** Use the Site only for lawful purposes. You must not use the Site to engage in any activity that is illegal, fraudulent, or harmful.

- We will contact you via the provided contact details to confirm details, discuss arrangements and formally confirm any booking. A reservation is only finalized when you receive an official confirmation (for example, a confirmation email or agreement).
- We reserve the right to decline or cancel reservation requests at our discretion (for example, if the venue is unavailable on the requested date or if the request violates any policy). If we must cancel or modify a confirmed reservation, we will inform you as soon as possible and work with you to find an alternative solution.

Intellectual Property

All content on the Site, including but not limited to text, photographs, videos, graphics, logos, designs, trademarks and software (collectively, the "Materials"), is the property of KYKLAMINO or its licensors and is protected by copyright, trademark and other intellectual property laws.

- Even after giving consent, if you change your mind, please contact us and we will promptly remove the photo/video in question from our Site or social media.
- Any photos or videos used will be in good taste, respectful and appropriate for a family-friendly audience. We do not use any media that might be invasive, sensitive, or compromising.

By attending events at KYKLAMINO, you acknowledge that photography/videography may be occurring. However, **no images of you or your children will be published without the appropriate consent.** We disclaim any liability for the appearance of individuals in group or crowd photos where they are not the focus and consent could not practically be obtained, but we will remove any such material upon request.
